
Based on the "A MEMORANDUM OF UNDERSTANDING CONCERNING THE ESTABLISHMENT OF ACADEMIC COOPERATION BETWEEN College of Electrical Engineering and Computer Science, National Taipei University of Technology and Sikkim Manipal Institute of Technology, Sikkim Manipal University," both institutions agree to conclude an agreement to specify terms and conditions of faculty exchange:

1. Both institutions will determine the number of exchange faculty each academic year and specify the length of stay intended for each faculty visitor based on the availability of openings and the number of qualified faculty members interested in participating in the program.
2. Faculty members participating in an exchange program shall be paid as a part-time instructor by the host institution in conformity with its regulations pertaining to part-time instructors and by the home institution in conformity with its regulations.
3. Each institution will apply its own procedure in nominating participants for the exchange program. The host institution will reserve the right to make final decision.
4. The exchange faculties are responsible securing their own accommodation. Each institution will provide necessary assistance in searching process. The financial conditions of the invitations, such as transportation, accommodation and salary are subject to the approval of both institutions.
5. Each institution will provide appropriate certificates of eligibility for visas and other documentations as required by government agencies in the host country.
6. The Agreement will be in effect from the date of signature for a period of five years. It shall be extended automatically for an additional period of 5 years at each expiration date unless either institution gives a six months' advance notice in writing to terminate the Agreement.


